- While at Good Shepherd, Karen oversaw many new clinical programs, as well as several ambulatory clinics, an extensive modernization project, the private bed pavilion, and outpatient testing center. More recently the new Health Management Center and the Center for Health and Integrative Medicine opened.
- Karen holds a MS from the Illinois Institute of Technology, as well as a BA from the University of Delaware. She is a
 Fellow with the American College of Healthcare Executives (ACHE).

- As Vice President for Human Resources, Manuel sets the overall strategic vision for Human Resources aimed at elevating Harvard's profile as a progressive, business-forward employer, recruiting and retaining diverse talent, providing development opportunities for all members of the University workforce of ~20,000, and serving as a thought leader on how Harvard can thrive in the workplace of the future. He has oversight of and responsibility for staff employment policies, labor relations, benefits and compensation programs for the entire University, and serves as the coordinating partner to the HR leaders at each of Harvard's 12 individual schools. He is also responsible for all aspects of HR for Central Administration (approximately 6,000 employees) and has oversight of Harvard's contingent workforce suppliers.
- Prior to joining Harvard in August of 2021, Manuel was Vice President for Human Resources and Chief Human Resources Officer at Northwestern University. Previously, he had a successful career as a labor and employment lawyer at Motorola Solutions, Inc. in Chicago, which culminated in his service as Chief Human Resources Officer and Corporate Vice President of Employment Law and Data Protection.
- He earned his BA from the University of Notre Dame and his Juris Doctor from the University of Puerto Rico, School of Law. He holds Information Privacy Professional (CIPP) and Information Privacy Manager (CIPM) certifications from the International Association of Privacy Professionals (IAPP), and a Master's Degree in Executive Coaching & Leadership from Universitat de Barcelona/OBS.
